The Fulcrum Foundation provides financial assistance to promote and support Catholic schools in the Archdiocese of Seattle primarily through tuition assistance, assistance to schools in need, and initiatives that promote academic excellence and faith formation.

Last year, Fulcrum received **3731 APPLICATIONS** for tuition assistance from families whose median annual income was just under \$25,000. Fulcrum was able to **FULFILL 36%** of those requests, translating to **1335 STUDENTS** receiving grants through our general tuition assistance program.
